



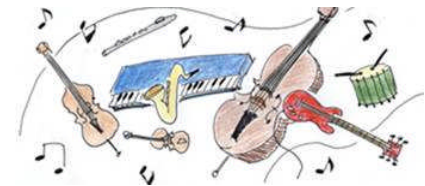
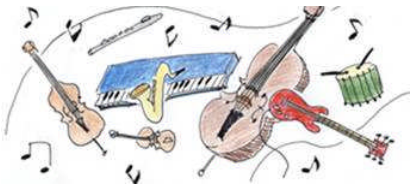
## YEOVIL TOWN STREET ENTERTAINERS

### YEOVIL TOWN WELCOMES QUALITY STREET ENTERTAINERS WHO HAVE A PERMIT AND WHO FOLLOW THE GUIDELINES IN THIS CODE OF PRACTICE

THE POLICE ARE AWARE OF THIS CODE OF PRACTICE. N.B. NO RIGHT TO PERFORM IS INFERRED BY THIS CODE OF PRACTICE AND IT DOES NOT CONFER IMMUNITY FROM LAWS AND LOCAL BYE-LAWS

# CODE OF PRACTICE

1. STREET ENTERTAINERS SHOULD ONLY PERFORM WITHIN DESIGNATED STREET ENTERTAINMENT AREAS.
2. STREET ENTERTAINERS MUST ONLY PERFORM IN THESE AREAS DURING THEIR ALLOCATED TIMES (9AM to 9PM DAILY).
3. FIRE EATERS MUST HAVE PUBLIC LIABILITY INSURANCE AND MUST LIAISE WITH THE LOCAL AUTHORITY, AND PRODUCE THEIR INSURANCE, BEFORE PERFORMING.
4. CIRCUS SKILLS PERFORMERS MUST HAVE PUBLIC LIABILITY INSURANCE.
5. NO SALE OF MERCHANDISE WILL BE ALLOWED WITHOUT PRIOR PERMISSION OF YEOVIL TOWN COUNCIL WHO ARE ADMINISTERING THIS SCHEME ON BEHALF OF SOUTH SOMERSET DISTRICT COUNCIL
6. AMPLIFICATION MAY ONLY BE USED IN DESIGNATED AREAS, AND SHOULD BE OPERATED AT A REASONABLE LEVEL TO ALLOW OTHER ACTIVITIES TO CONTINUE UNHINDERED. ANY REQUEST BY A POLICE OFFICER OR OFFICER OF YEOVIL TOWN COUNCIL OR SOUTH SOMERSET DISTRICT COUNCIL TO REDUCE THE LEVEL OF AMPLIFICATION MUST BE COMPLIED WITH IMMEDIATELY.
7. NEITHER STREET ENTERTAINERS, NOR THEIR MONEY COLLECTION CONTAINERS SHOULD BE SO PLACED AS TO ACT AS AN OBSTRUCTION TO PASSERS BY.
8. STREET ENTERTAINMENT WILL NOT BE PERMITTED IN NON-DESIGNATED AREAS.
9. STREET ENTERTAINERS WHO ARE UNDER THE INFLUENCE OF EITHER DRUGS OR ALCOHOL WILL NOT BE PERMITTED TO CONTINUE, AND WILL HAVE THEIR PERMIT REMOVED.





## YEOVIL TOWN DESIGNATED STREET ENTERTAINMENT AREAS

### YEOVIL TOWN CENTRE ENTERTAINMENT AREAS:

#### STREETS

Bond Street, Central Road (from the Labour Club to Middle Street), Church Path, Church Street, Clarence Street, Glovers Walk, High Street, King George Street, Middle Street (including lower Middle Street), Park Road, Peter Street, Princes Street and pathway running past United Reform Church through to Clarence Street, Silver Street, South Street, Tabernacle Lane, Union Street, Upper Hendford, Waterloo Lane, Westminster Street and Wine Street.

#### OTHER AREAS

Area known as the Borough (by War Memorial), Bus Station areas adjoining Central Road, Petters Way Car Park (both), area of grass at Reckleford junction with Eastland Road, St John's Churchyard adjoining the church (all sides), car park adjoining Churchyard (south of North Lane) and car park adjoining Waterloo Lane (known as Tesco's covered car park).
