The Planning Assistant explained that the fascia sign was proposed to be internally illuminated with LED lights and externally illuminated with downward pointing trough lighting. She added that the projecting sign was proposed to be internally illuminated with LED lights.

RECOMMENDED REFUSAL of all illumination due to unacceptable light pollution, although the signs without illumination were considered acceptable.
