proposals to improve the visual appearance of the nearby underpasses at the end of Princes Street.

Members who represented the Town Council on outside bodies were given an opportunity to report on any matters of interest.

David Dollard referred to a recent seminar that he had attended, which had been organised by the Local Strategic Partnership, entitled "Meeting the Skills Needs of Industry".

He explained that the aim of the event had been to discuss and gather views on what was needed to meet South Somerset's business skills needs and to develop a skilled workforce to address the gaps. David outlined the main points that had arisen at the event, at which local employers Numatic International and EDF Energy had been represented.

Phil Chandler referred to the recent expansion of the area covered by the Newtown Tenants and Residents Association and plans to broaden the local Neighbourhood Watch Scheme to encompass the larger area.

Bridget Dollard drew attention to the new holiday activity scheme that had recently been held at Yew Tree Park with the financial support of the Town Council. She added that the introduction of this additional scheme meant that all four wards of the Town now had such schemes operating in their respective areas, access to which was freely available to local young people.
